## 2. A short description of the research project (max. 1000-1500 characters). The description may be used in the published report and / or the TIAS website.

- As a piece of cultural history, the research project addresses the problem of studying an artist as a processual thing or agent by focusing on German author, critic, lawyer and composer Ernst Theodor Amadeus Hoffmann (1776–1822). Having its historical parameters in early Romanticism, the project shows the way in which a group of agents or bodies named "E. T. A. Hoffmann" was constituted through various practices and material processes peculiar to his life. Discussing the unexpected and transformative aspects of his life and works, the becoming of the artist, the essay maps these issues as productive points for further consideration. The scrutiny is based on Gilles Deleuze's notion of individuation, and it also uses concepts and ideas familiar to new materialism.
- This project investigates the visual processing skills needed for the successful reading of music notation through eye-tracking methodology. So far, knowledge on the development of music-reading skill and the related teaching practices are mainly based on intuition and tradition, as research on the topic has been somewhat scarce. Therefore, a systematic study of the different stages of learning to read music notation is needed in

order to refine the current teaching methods.

In the present project a series of empirical studies, all applying eye-tracking methodology, address several aspects related to sight-reading, rehearsed reading and silent reading of music notation. The ultimate goal for the project is to suggest a model on the course of eye movements in music reading. The findings of the project will not only serve the educational practices related to learning and teaching music, but the multifaceted topic also allows the findings to contribute to research on music education, educational psychology and cognitive musicology on a more general level.

The project will be conducted in close collaboration with the multidisciplinary research consortium between the University of Turku (Department of Teacher Education) and the University of Jyväskylä (Department of Music), titled "Reading Music: Eye Movements and the Development of Expertise in Music" (funded by the Academy of Finland, 2014-2018).

My project aims at a quantitative analysis of the characteristics and distinguishing features of a large collection of different Internet texts in French, using automatic morphological and full dependency syntax analyses, i.e. the detection of word forms and their functions in the sentence as well as the identification of the entire sentence structure.

The corpus of the study consists of a combination of private corpora collected for the purposes of other studies: French politicians' blogs and comments, chats from different news sites, discussion forum texts from student sites and from news sites as well as follow-up discussion of Le Monde editorials.

The automatic morphological and syntactic analyses will be done using the TALISMANE toolkit developed in the University of Toulouse-Le-Mirail. If necessary, a syntax parser specifically for the analysis of Internet texts will be constructed in collaboration with the original developers of the tool by annotating a small collection of example sentences of this project corpus and by combining these to the existing parts of the toolkit.

This research project aims at creating new understanding on the dynamics of collaborative innovation in service networks. In the increasingly specialized markets, the creation of new value propositions requires accessing and connecting the resources of diverse organizations in multiple industries. Resources residing outside the firm's boundaries are of particular importance for service and solutions offerings characterized by interaction processes that are lengthy and iterative, requiring reciprocal contributions by the parties. Recent research has also emphasised the role of not only R&D partners but also the surrounding stakeholders in shaping the success of an innovation at the market and society levels. By drawing on multiple case studies and extensive cross-country survey data, this project examines i) how firms seek and integrate external resources for the purpose of service/solution development; ii) what are the organizational arrangements and practices through which firms develop services and solutions; iii) how can innovations be managed in broader service systems. This research broadens existing knowledge especially on service innovation processes and organizational configurations that take place within networks where various social contingencies as well as informal arrangements come into play.

In my project I study the ethical foundation of new biodiversity conservation approaches on the one hand, and genome editing techniques and synthetic biology on the other. In practice this means undertaking terminological and conceptual clarifications, argumentation and policy analyses, ethical assessments, and philosophy of science-based analyses. The project is carried out in close collaboration with the assisted migration research group at the Finnish Museum of Natural History, University of Helsinki, and the Division of Philosophy at the Royal Institute of Technology, Stockholm.

The aim of the project is to conduct research on the following food related terms: authenticity, naturalness, purity, and healthiness. The following questions regarding them are answered. (1) What different meanings these terms have in the context of food? (2) Which, if any, of the identified meanings offer good justifications for individual food choices and for local and global food policies? The methods of the project are non-empirical and philosophical.

My research project studies television programme format as cultural negotiation. Today, television programme formats are an integral part of the mass media and popular culture, but the global format trade is also major business. As many format scholars now agree, cultural adaptation of programme format is not only about filling the format with local contents, but rather, a negotiation between different television cultures. Television cultures are formed and transformed in the interplay of structures and human agency, of production, text and reception, and of national and international. Thus, I suggest, that programme format should be seen as cultural negotiation, in which new forms of culture are produced by assimilating and adapting international and national influences and elements on various sites and levels.

Theoretically and methodologically, my study draws on format studies, media industry studies and structuration theory. By combining several, previously separate, traditions of media industry research exploring media texts, audiences, histories and (production) cultures, the research my aims at developing a new approach on studying formats. The main body of my research material consists of thematic interviews with television producers and managers. The interviews are complemented with other materials, like television schedules, programme texts, production documents, focus groups etc. The 3-year project is not yet finished as I only received TIAS funding

## Governance of Higher Education through OECD Future Scenarios

The present research focuses on analysing the past and current higher education future scenarios of the OECD and the congruence of these scenarios with national scenarios for higher education in Finland, France and the United States. The key research questions are:

### 1. Examination of the OECD's scenarios:

Which kinds of alternative future scenarios has the OECD presented on the higher education policies of its member countries from the 1960s to the present? What are the essential differences and analogies between the latest OECD scenarios and those preceding them? Which aspects are presented as ideal (utopian) and undesirable (dystopian) future alternatives in the OECD scenarios? Which of the alternative scenarios have become reality and why? Which scenarios did not materialize and why? How have the scenarios become a part of educational governance?

### 2. Comparative study approach: National future scenarios

Which kinds of alternative future scenarios for higher education policy have been presented in Finland, the United States and France from the 1960s to the present? Are there shared features or equivalencies between the scenarios in the three countries? Is there congruence between the scenarios on the future of higher education presented by the OECD and national future scenarios in the three target countries? I review the corpus of runic inscriptions from Scandinavia to assess the possibility of Finnic and Sámi elements, reevaluating earlier proposals and undeciphered inscriptions and names in relation to archaeological, linguistic and onomastic evidence for contacts. Although the languages are known to have been in close contact, this possibility has not been systematically explored. This neglect is due in part to a dearth of scholars with appropriate expertise and in part to outdated assumptions about language contacts. Proposed readings have suffered from anachronism or been left undeveloped, and the runic community has often dismissed the possibility of inscriptions in non-Germanic languages other than Latin. I will also evaluate the evidence for a historical runic presence in Finland in the light of recent finds and changing understandings of runic literacy.

Bullying is a form of aggression displayed during childhood and adolescence, often having serious consequences both for victims and perpetrators. To combat and prevent such adverse effects, development of effective interventions is important. One of the most successful interventions against bullying is the KiVa program (PI Prof. Salmivalli, University of Turku). However, the intervention is not effective for all individuals, and the reasons behind this are still unclear.

In order for interventions to be as effective as possible, it is vital that we understand the etiology behind bullying and what explains variability in intervention efficacy. To date, the majority of studies on bullying have not taken genes into account although aggression is highly heritable. Besides main effects of genes and environmental factors, interactions between these factors are common. Individuals might, e.g., react differently to the effects of an environmental factor, such as the KiVa intervention, due to their genotypes.

This project examines to what extent genetic and environmental factors influence bullying and victimization as well as investigate if the genotype of an individual moderate the effectiveness of the KiVa intervention using a subsample of twins from the KiVa-sample. The results of the proposed research program will significantly improve our understanding of both genetic and environmental influences on bullying as well as on the efficacy of anti-bullying interventions.

"From Poetry to Intersectionality: Reading Feminist Experience Across the Theoria/Poiesis -Binary" is a project which focuses on the literary analysis of feminist "identity poetics" dating back to late 1970s and early 1980s period of so called essentialist writings. My primary sources consist of the "theoretical poetry" written by the following feminist poet/scholars: Latin-American Gloria Anzaldúa, and Caribbean-American writers Michelle Cliff and Audre Lorde. Their poetic styles are compared to the Jewish-American feminist Adrienne Rich's poetry. However, my focus is not on writing history of Women's studies. I will re-explore the period of identity politics, in order to map the roots of contemporary intersectional methodology - and thus provide a genealogy for intersectionality.

My aim is to analyse the poetic plasticity of the feminist theorizing and its ability to evolve through the poetic elements: Through the literary analysis, I will acknowledge the poetical claims the non-Western scholar/poets made on Academic feminism of that time. While the "theoretical poetry" was often included in their academic contributions or otherwise scholarly collections, it remains largely understudied by both, the feminists of that period and the literary scholars.

Religious imaginaries and modernisation: The dynamics of world-making among Amazonian Indigenous Christians

This project explores the role of religious imaginaries in shaping people's lived worlds. More specifically, it concentrates on the ways in which different Christian imaginaries affect people's understandings of the self, the

other and the transcendent, and on how, if at all, in doing so, Christianity works as a modernising force in people's worlds. Research material in the study will be formed among Indigenous Yine second generation Christians living in the Peruvian Amazonia.

The principal motivator behind the project is in social sciences widely discussed problem concerning the relation between Christianity and modernisation: is Christianity, when spreading to new locations, an inevitably modernising force?

The project approaches the question of modernisation and Christianity through the notion of 'imaginaries'. The imaginary here does not signify the untrue or non-existent, but is firmly attached to the present. The activity of imagining depends on the existing social and material conditions and is therefore necessarily social, however individually exercised.

- Laboratories and simulations have been treated as competing means in science teaching. Recent empirical studies suggest that the innovation to combine simulation and laboratory is an effective way to teach and learn science and that potentially it might also have an effect on students' interest. At the same time research has also suggested that abstract representations might enhance transfer of learning.

The aim is to investigate the effects of simulations and laboratory simulation combinations and of concrete and abstract representations in instruction to on learning and interest, and explore theoretical explanations on how characteristic of these learning environments and of the students interacting with the environments affect learning in these environments.

Theoretically, the results can extend current understanding of learning with multiple representations and analogical encoding, the importance of cognitive and motivational characteristics for learning and the influence of changes of learners' on-task characteristics on learning. Pedagogically, the outcomes of the project will provide contributions the improvement of science learning in terms of exploring and rigorously testing innovative and effective ways to integrate real and simulated learning experiences and for of learning environments designs that take cognitive and motivational characteristics into account.

- This study contributes to feminist theory, gender and sports history and science and technology studies. This study takes a new look to the history of bodily sex as a transformable phenomenon, and to the history of the hormonal moulding of bodies. This study focuses on a case which has not yet received attention in the gender-sensitive, critical histories of hormone technologies: the scientific, technological and political developments related to 'sex hormones', where their effects on the so-called sex characteristics of bodies were not regarded as the essence of what these phenomena are. In the projects studied here, the effects on 'sex characteristics' were instead considered unwanted side effects. This study focuses on both scientific and public debates related to anabolic steroids, synthetic products where such 'side effects' were minimized. The study contributes to the analysis of how hormone technologies have been used – intentionally or unintentionally – in blurring the boundaries between female and male, and how such boundary-crossings have been negotiated both within science and in public. The study concentrates on the time period from 1950s onwards when the idea of anabolic effects of steroids was explored enthusiastically for various purposes, and before anabolic steroids were classified as 'doping' in sports. The discussions around 1976 are included, when anabolic steroids were for the first time prohibited and tested in the Olympic Games.

- During my TIAS-time, I concentrated on two interrelated projects: on the research on growing cultural significance of children in fashion as models, and on the growing cultural visibility on pet dogs as fashion-consuming "new children".
- Customer value has long been considered as one of the key concepts in marketing, especially in B-to-B domain. Despite the consensus about why firms must focus on customer value, we still lack knowledge of how to effectively implement customer value concept in business markets. This research project on value-based selling explores a fundamental question how to make customer value-based strategies operational at functional customer facing levels. Research project contributes by examining the individual and organizational level antecedents, outcomes and contingencies of value-based selling based on multilevel data from almost 1000 salespeople nested in 43 international sales organizations. The international research project, done in cooperation together with leading scholars in this area has already led to several publications including publications in JUFO-3 ranked Journals. Based on a multilevel analysis of a unique dataset, the research shows how the interplay between organizational and individual conditions makes value-based selling a success. Currently, all key articles of the project have been published or manuscripts are under review in leading JUFO 3 level Journals. The project has been broadened to buying organizations viewpoint through a new funded "Value Transformers" research project.
- Myths, Cultural Tools and Functions – Historical Narratives in Constructing and Consolidating National Identity in 20th and 21st Century Estonia.

This research project aims at analysing and understanding the interplay of academic writing of history and political power in Estonia in 20th and 21st centuries. Since the regaining of independence in 1991 the meaning of individual memories, cultural and communicative remembering and historical knowledge has been a subject of debate not only among historians but also politicians, cultural persons and journalists. This project focuses on the various ways in which historical knowledge, narratives and myths have been employed in political

speeches, interviews, articles, resolutions and memoirs produced by Estonian politicians. These texts, as well as popular and academic history books will be analysed in the context of uses and functions of history and historical knowledge in the society. Thus the project also aims at producing methodological categories and concepts applicable to other modern societies as well.

In 2016, I have edited a special number in English for the Estonian Historical Journal with two other editors and publishes peer reviewed journal article and several other articles. In addition, I have worked with three article manuscripts, all of them will be submitted to international peer-reviewed journals. I have also worked with two manuscripts of monographs.

- Genre and Gender. Gender and Sexual Normativity and Subversion in Contemporary French Crime Fiction

The research project uses queer gender theory to examine to what extent, and in which forms, explorations of gender and sexuality occur in contemporary French crime fiction. Its aim is to demonstrate how generic traditions, as well as formulaic codes and rules concerning narrative structure and plot, condition both normative reiteration and subversion of gender and sexual norms in the crime genre. Such tropes are for example, the hermeneutic code, transgression, character types, violence and crime, representations of bodies, ratiocination, and the teleological move from ignorance to knowledge.

- This research project is aimed at investigating service transition strategies of industrial manufacturers with particular emphasis on solution business. The focus is on issues that facilitate the provider's transition process and help to ensure successful implementation of the resultant solution business model. The specific research questions are stated as follows:

1. How can solution providers simultaneously ensure so called external effectiveness at the customer interface and internal efficiency of operations to ensure that solution business initiatives result in greater value added, both for the provider and the customer?
2. How do solution providers organize themselves to seek access to and integrate resources required for successful solution business?
3. How can firms create sufficient organizational continuity with existing product based business operations when transitioning to solution business in order to avoid transitional problems?
