Principles for the protection of data

The register data is stored according to the best practices, good information security and legislative regulations so that it is protected from external parties. The register is protected with user identification and passwords as well as structural and group-specific authorisation. Registers containing personal data can be accessed only by the members of personnel who require the use of personal data for performing their work tasks. The system can be accessed only through a protected network connection.

An agreement on the terms regarding the processing of personal data, which is in accordance with the EU General Data Protection Regulation, has been made with the system supplier (eTaika Oy).

The use of the service creates log entries which are used for ensuring the information security of the service, developing the technology of the service, and for detecting, preventing or investigating technical faults or errors (Sections 138,141,144, and 272 of the Information Society Code (917/2014)). The logs are retained for these purposes for the required time period and they will not be used for any other purposes.
